President's Report

- On July 11, the minutes of the July 6 monthly Board of Directors (BOD) meeting were approved via email vote (10 Ayes, 2 missing votes)
- On July 13, the BOD voted via email for the Summer Series II to go forward on July 14 (6 Ayes, 3 Nays, 1 Abstain, 2 missing)
- On July 15, the BOD approved the COVID-19 guidelines for the fall New Energy program via email vote (10 Ayes, 1 Nay, 1 missing)
- Summer Series and Scholarship 5k went well; there were issues during the 5k with social distancing despite frequent reminders by the DJ during the event. The City of Norfolk had also received a phone call about it, which was passed on to the Botanical Gardens. This social distancing issue was fixed for the Strider's Mile. There was no social event afterwards and competitors were kept separate.
- Upcoming Races update: The Strider 10-miler is now virtual. ERR for 2020 has been canceled. Mel Williams 5k is still scheduled for September. Turkey Trot is still scheduled for November. The Strider XC Classic is waiting for permit from Chesapeake. Eight Grand Prix races are remaining, with four completed. The Mulberry Half Marathon and the Jamestown 10k, two Super Grand Prix races, have been canceled. The Heart of Ghent Run Fest has been cancelled.
- Board members will be needed to assist during future races, particularly as Social Distancing Ambassadors during the September 13 Mel Williams Memorial Race.
- The course for the May 29, 2021 ERR has been approved by the City and ODU. It will start at ODU and the finish will be off Terminal Boulevard; Sentara is presenting Sponsor. Packet pickup will be at Smartmouth Brewing the night before. The ERT Foundation will handle the after-party and the majority of the advertising.

Vice President's Report

- Picnic was cancelled after discussions with Jean Phelan and Thomas Hicks. Because of the COVID-19 restrictions, the Board voted 11:0 to approve the cancellation. This will affect voting on bylaw changes, which requires a quorum of 40 members.
- The volunteer party at Ocean View Pier, usually held in November, should be discussed in September. The club may have to find a larger venue.
- Hall of Fame: There are currently four nominations.
- The club's history is up to date through July.

Treasurer's Report

- Tim provided the July Financials (attached)
- Scholarship monies were distributed
- NCAA runners cannot run for any Striders' teams and receive scholarships
- Tim is starting to work on the budget

Committee Reports

The following committee updates were provided:

- **Audit (Tim Westfall):** Audit is in progress; Tim received 3 months' worth of documents from the Treasurer. Tim suggested that Scholarship recipients be asked to provide feedback to the club. They could also be interviewed for the RUNDOWN.
- **Constitution & Bylaws:** Peter moved to hold the general membership vote on the bylaw revisions via email. The motion was seconded by Marie Price and unanimously approved.
- **Multisport: (Bob Boyce):** All races for the Multi-Sport Grand Prix for 2020 have been canceled. Therefore, it is recommended that the 2020 Multi-Sport Grand Prix be canceled.
- **Marketplace: (William Tallent):** Added medal holders. There are about 100 neck gators left, which will be put out for sale.
- **Media: (Jean Phelan/Jim Martin/Andrew Hoffer):** Jim updated Grand Prix rules and the walkers interest list on the web page. There were 70 new Instagram followers and 50 Facebook followers. Andrew reported that Striders' Podcase Episode #16 is forthcoming, featuring Marie Price. It was suggested to add multi-sport and walker episode(s) in the future.
- **Membership: (Bob Brunner):** There 1,826 members and 1,137 memberships at the end of July. This total is similar to last month and slightly below from last year. There were 85 membership transactions in July involving 137 members. Randy reported that he has received positive feedback for following up on expired memberships.
- **Programs: (Kim Borges):** Reached out to a strength & custom orthotics person to talk at next event. Striders had a good showing of "Thrive" team at Scholarship 5k; Thrive now offers a member discount ("runner package"). Jim will add a link about the discount to the web page.
- **Race: (Dan Edwards/Thomas Hicks/Bunny May):** Thomas followed up on the Virtual Boston Marathon. There will be shirts for the registered participants.
- **Walking: (Bunny May):** The walking committee report is attached. The committee requested and Thomas agreed that a Walker Division be designated on all TS race registrations-virtual and live-in order to allow sign ups as Walkers to assist in creating data on interested walkers and promote the Walker Division. It was up to the Race Directors for Walker Awards.
- **Youth: New Energy** is ready to start back up September 14 under the new COVID-19 guidelines. Thomas was approached by high school coaches in the area because of the cancelled fall cross-country season. Steve Sheppard is discussing details with a few of the local high school coaches to establish a New Energy high-school division and have them join us at our training sites.

New Business

- Steve Armitage praised the work of the photographers at the Striders' events
- Jim announced that Point 2 Running Company has a sidewalk sale August 15 at both store locations
- Thomas recommends that board members wear a Striders' singlet at Striders' events to represent the club.

Thank you, Jim and Jean, for helping to get out the message for these three Walker Meet Ups! An email was also sent out to all Walkers on the Walker List posted on the Walker Page – starting to receive some feedback on both methods of contact.

3. Walker concerns:
Walker sign up on race registrations – Strider Scholarship Race-concerns expressed by 3 walkers – upon picking up bib was directed to the timer table to give them a name to bib number so they could track walkers. Upon reviewing their results, no walker section, no name connected to their bib number but all other data correct. No recognition of walker winners – was told no Walker Division-just 10' early start and no awards.

No Walker Division was on registration link for Strider Mile – Thomas had a link generated and moved already registered walkers to Walker Division.

The Walker Committee would again like to request a Walker Division be delineated on all TS race registrations – virtual and live – in order to advertise the Walker Division and to gather data to see how many TS members and non-members are interested in officially “walking” these races. Walkers are paying the same amount of TS membership dues and race fees. Walkers should be eligible for race awards the same as runners and runners/walkers.

Timing Contract: The Timing Company Contract for TS races should include the ability to time Walkers and present results the same way that runners are timed and results listed – Overall Male/Female, Age group awards as determined by the Race Director.
